### **DECISION** *on Contract Award*

In the negotiated public procurement procedure PPJN 1/2020 for the execution of the second phase of Serbia's inclusion on the map of word gastronomic destinations, the Public Procurement Contract is *awarded to*:

#### **Rationale**

By a decision of the National Tourism Organisation of Serbia, number 521/1 as of 24.02.2020, a public procurement procedure has been initiated for the procurement of services: The second phase of Serbia's inclusion on the map of word gastronomic destinations.

The name and designation from the general procurement vocabulary:  
Research and development services and related advisory services, GPV: 73000000.

The type of public procurement procedure: negotiation procedure in line with of the Article 36, paragraph 1, item 2) of the Public Procurement Law, based on the opinion of the Public procurement administration number: 404-02-729/2020 as of 20.02.2020.

The total estimated value of the public procurement is 21,600,000 dinars excluding VAT.

The invitation to bid was sent to: Michelin Travel Partner, 27 Cours de l'Ile Seguin, 92105 Boulogne Billancourt Cedex, France.

The bid opening procedure was held on 20 March 2020 beginning at 11:15 AM at the premises of the National Tourism Organisation of Serbia at the address: Belgrade, 8 Čika Ljubina Street, in the absence of the bidder.

The opening of bids was led by the Commission comprising of:

In a timely manner, i.e. by 20.3.2020 at 11:00 AM, Michelin Travel Partner, 27 Cours de l'Ile Seguin, 92105 Boulogne Billancourt Cedex, France, has submitted its bid registered with the Contracting authority under the number 889 as of 20.3.2020 at 10:00 AM.

The tender documents foresee that the negotiations shall be carried out immediately upon the opening of the bids and if the authorised representative of the bidder does not attend the negotiations and does not submit a new bid, the final price shall be the price stated in the submitted bid.

Having in mind that the representative of the bidder was not present during the bid opening, the offered price shall be deemed final.

During the expert evaluation of bids, the Commission has confirmed that the received bid is timely and acceptable.
