After completion of the small value public procurement, pursuant to Articles 107 and 108 of the Public Procurement Law (Official Gazette of RS, No. 124/2012, 14/15 and 68/15) and the Report on Technical Evaluation of Bids on November 20<sup>th</sup> 2019, the National Tourism Organisation of Serbia as the Contracting Authority hereby passes this

**DECISION**  
*to award contracts*

In the small value public procurement, SVPP No. 15/2019, for procurement of public relations services on the Italian market for procurement contracts are hereby awarded as follows:  
„Mailander S.r.l“, Torino, Italy, Via Cavour 21 .

**Explanation**

Subject of this public tender is provision of public relation services on the Italian market.  
Title from the general registry of public tenders: 79416000 -Public relation services  
The type of public procurement procedure: small value public procurement  
The total estimated value of public procurement is RSD 3.550.000, exclusive of VAT.

Opening of bids took place on November 19<sup>th</sup> 2019 at 11:15 a.m. at the premises of the National Tourism Organisation of Serbia, address: Belgrade, Cika Ljubina 8.

Opening of bids was made by the Commission, consisting of:

- 1) Aneta Uskokovic, Tourism associate for international tourism market, chairperson
- 2) Olga Stojanovic, BCC, Associate for international tourism market, member
- 3) Jelena Bogdanovic, Public Procurement Officer, member

On the opening of the Bid no representative of the bidder was present.  
Just one bid was received timely, i.e. by 19 November 2019 at 11:00 a.m.  
There were no late offers.

The Bidder offered the following criteria elements:

\* Amounts were converted to dinars at the middle exchange rate of the National Bank of Serbia applicable on 19th November 2019, which was 117,4826 RSD for 1 EUR.

In the process of the expert evaluation of the tender, the Public Procurement Commission stated that the offer of the bidder "Mailander S.r.l", Turin, Italy, Via Cavour 21, was acceptable and suggested for public procurement contract to be awarded to the bidder:

„Mailander S.r.l“, Torino, Italy, Via Cavour 21 .

On the basis of the facts found in the procedure, it was decided as stated in the enacting clause of the Decision.
